

## MEDICAL STAFF ASSOCIATIONS IN NOVA SCOTIA **GRANT APPLICATION** APRIL 2019

## Introduction

edical staff associations (MSAs) help to facilitate a professional and collaborative work environment that actively engages physicians in health-system planning. Across Canada, MSAs have been growing and helping advocate for physician inclusion in all matters that govern the practice of medicine, facilitate communication with health-system partners, and bring the voice of physicians and the communities they serve to all levels of decision-making within the health-care system.

Robust, active, MSAs already exist in some communities of Nova Scotia, but in other areas they have yet to be established. There are presently no formal zonal MSAs. Doctors Nova Scotia (DNS) is committed to supporting its members as they work to establish or improve MSAs in their communities.

Doctors Nova Scotia commissioned a suite of MSA resources and developed the DNS MSA Grant program to help physician communities establish or grow an existing MSA. Members of new or established MSAs may apply for this one-time allocation of funds (worth up to \$10,000 per grant). The purpose of the grant is to:

- Support the establishment of a new community-based MSA
- Support the establishment of a new zone-based MSA
- Support the ongoing work of an existing MSA

# Grant application guidelines

### Who can apply?

- Each community or zonal MSA may submit one application. Individuals cannot apply for the grant but a group of four or more physicians interested in creating an MSA can apply together.
- To be considered an official MSA, the MSA must have: an Executive Committee and terms of reference.

#### What type of initiative is eligible?

- Eligible initiatives include:
  - Initiatives related to starting an MSA, such as hiring a consultant to help develop a governance model
  - Initiatives related to supporting an existing MSA, such as providing continuing medical education (CME), doing advocacy work or recruiting
- Initiatives that are ineligible for a grant include: social events, construction, paying off debt or paying salaries, funding special awards.

#### What is the process?

The DNS MSA Grant application process will include the following steps:

- Call for applications (Intake 1: May 1 to July 15, 2019; Intake 2: Oct. 1 to Nov. 15, 2019.
- Applicant MSA will complete and submit the grant application (see page 4).
- Submissions will be reviewed by the DNS MSA Grant Application Review Committee (consisting of at least two DNS staff and the DNS President) in accordance with the selection criteria.
- Applicants will be notified of the outcome.

The total amount of funding available is \$80,000. Grants are a one-time allocation of funds, and will not exceed \$10,000 per successful application. The size of each grant will be determined by need and how well the application fits the selection criteria.

#### What are the requirements for reporting?

Grant recipients will be required to agree in writing to terms and conditions pertaining to the DNS MSA Grant program. All grants awarded will be provided in full upon receipt of the signed terms and conditions document.

Six months after receiving the funding, all grant recipients are required to submit a short written evaluation explaining how the funds have been spent and what outcomes have been achieved.

#### **Application** criteria

To apply for a grant, applicants are required to submit an application (see page 4) that meets the following mandatory criteria:

- It must be fully completed and submitted by the application deadline.
- It must clearly identify how the grant funds will be allocated to support the formation or growth of an MSA.
- If an existing community-based MSA is submitting a grant application, the application must be signed by the members of the **Executive Committee.**
- If a new community MSA is submitting a grant application, the application must be signed by a minimum of four participating physicians.
- If a new zonal MSA is submitting a grant application, it must be signed by a minimum of four participating physicians, with at least one physician from each participating community.

#### Selection criteria

The application will be ranked by the DNS MSA Grant Application Review Committee using the following criteria:

<ul> <li>Does the grant application explain how the MSA plans to continue once funding runs out, given this is a one-time grant?</li> </ul>

#### Be strategic
