Doctors Nova Scotia is the collective voice of physicians in Nova Scotia. On behalf of the province's doctors, the association is committed to working with all partners in health-care delivery to ensure Nova Scotia is positioned to recruit and retain talented and skilled doctors, introduce new and innovative ways to deliver health care, and to continuously look for ways to improve patient care and access.

Doctors Nova Scotia is governed by its Board of Directors, a group of physicians that provides the association with its overall strategic direction.

The 2021–27 Strategic Plan calls on the association to:

- Connect and engage physicians
- Advocate on behalf of physicians
- Serve physicians by providing effective member benefits and services

To serve our members, DNS:

- Negotiates physician remuneration with the provincial government
- Acts as the medical profession's united voice on health-care issues that affect physicians and their patients to the public, health-care stakeholders and the government
- Influences and supports the development of health-care policies
- Offers programs and services to support physicians throughout their career
- Offers a comprehensive package of member benefits and services

## Our commitment to equity, diversity and inclusion in health care

Doctors Nova Scotia sits on and operates in Mi'kma'ki and Unama'ki, the traditional and unceded territories of the Mi'kmaq. At DNS, we honour and respect the Indigenous people of this land. We also know that we have much more to learn and to do to embrace the Calls to Action from the Truth and Reconciliation Commission, especially those related to health care.

Doctors Nova Scotia also acknowledges that African Nova Scotian history goes back more than 400 years. African Nova Scotians have also experienced systemic racism, oppression and colonialization, the consequences of which continue to reverberate today.

Racism against Black and Indigenous people and people of colour is a serious problem in health care, for both patients and providers. Racism is a public health issue, and people who experience racism report receiving poorer health care and ultimately have poorer health outcomes.

Racism in health care is also experienced by health-care providers, including physicians, who are Black, Indigenous or people of colour. One major concern is that health-care institutions are largely governed by white people, even though health-care systems and practices rely on the labour of health-care providers, support staff and researchers who are Black, Indigenous or people of colour.

Doctors Nova Scotia is committed to addressing health inequities in the province's health-care system by working with Indigenous and African Nova Scotian leaders, the medical community, physicians and system partners to disrupt systemic racism, decolonize the health-care system and improve the health-care experiences of Black, Indigenous and people of colour in Nova Scotia. We are all Treaty people. This work will continue to evolve, but has already begun with the following:

- Equity, diversity and inclusion are now a cornerstone of the association's 2021–27 Strategic Plan. A comprehensive EDI framework has been created to support this work.
- Doctors Nova Scotia has included equity, diversity and inclusion training for physicians at the association's last two annual conferences (2020, 2021), and facilitated training sessions for Board and staff members and Sections.
- Doctors Nova Scotia members have formed the Section of Physicians for Indigenous Health, a forum where physicians can share knowledge, experience and training in the unique health challenges faced by Indigenous populations, cultural safety issues and the social determinants of health.

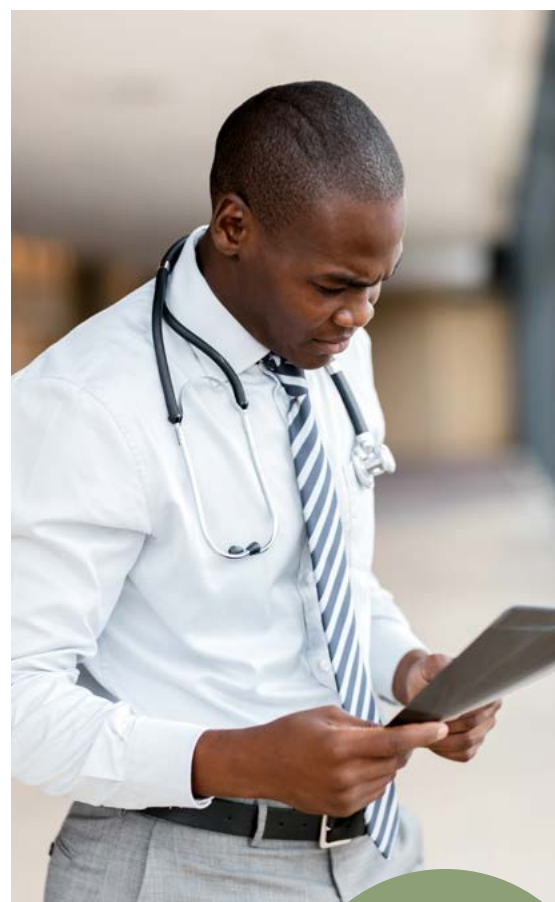

### MAINTAINING YOUR MEMBERSHIP

#### Retired members

A former full member who is fully retired from the practice of medicine and no longer holds a medical license is considered a retired member. Retired members are entitled to all the rights and privileges of the Society, including the right to hold office and vote.

#### Members on leave

Members still holding a medical license but retired from active practice are considered a member on leave and will pay the membership dues for that member classification.

#### Life members

Any member of Doctors Nova Scotia in good standing for the immediately preceding 10-year period and who has attained the age of 65 years is eligible for life membership. Nominations may be made by any full member of the association.

# Extended Health and Dental Plan

**D**octors Nova Scotia (DNS) offers its members a comprehensive health and plan administered by Canada Life. New members are eligible following a three-month waiting period.

Health and dental plans are available for individuals and families, and are divided into two categories: 64 years and under, and 65 years and older (senior). Eligible dependents include a member's legal or common-law spouse and children (natural, adopted or stepchildren).

Satisfactory evidence of good health isn't required if application is made within 60 days of first becoming eligible. If you receive coverage from more than one insurance company, you can coordinate your benefits to cover (but not exceed) 100% of the actual expenses incurred.

### PLAN PREMIUMS

Single plan – \$690  
Family plan – \$1,415  
Senior single plan – \$475  
Senior family plan – \$1,025

Upon enrolling in the association's extended health and dental plan, you will receive an information booklet from Canada Life containing full details of your coverage. The chart provided here is a handy reference guide. In the case of a discrepancy between the information presented here and that in the plan booklet, the booklet takes precedence.

### PARENTAL LEAVE PROGRAM

The Parental Leave Program offers paid parental leave benefits to eligible DNS members who wish to take time off to care for their newborn babies or newly adopted children.

The program provides \$1,500 per week for up to 17 consecutive weeks. Members will be eligible for this benefit as long as they reside in Nova Scotia, maintain a Full membership or Special Consideration: Members on Leave membership with DNS while on leave and have billed at least \$50,000 in the 12 months preceding baby's date of birth or date of taking over care of an adopted child. ### Physician leadership development

Doctors Nova Scotia offers many leadership training opportunities for physicians, including several opportunities each year to take two- or three-day Physician Leadership Institute (PLI) courses. Physicians interested in more in-depth training may apply to participate in the longer-term Physician Leadership Development Program (PLDP).

## Physician Leadership Development Program

Doctors Nova Scotia has collaborated with CMA Joule Inc. to offer a Physician Leadership Development Program since 2018.

The PLDP aims to enhance the skills of experienced physician leaders to influence health-system decisions that affect doctors and patients. The program will create more visionary, collaborative, effective leaders in health care.

Program participants will collaborate on an action learning project, working to find solutions to complex, real-life problems in collaboration with their colleagues and partner organizations (including Nova Scotia Health, IWK Health, Dalhousie Medical School and DNS). The project provides an opportunity for participants to apply the skills they are learning.

The program, designed specifically for Nova Scotia physicians and delivered by physicians and leadership experts, focuses on integrative systems thinking and other key skills necessary to lead in an ever-changing health-care environment.

Program participants must commit to attending six, two-day modules, to be completed over a six-month period.

## Contract Support

**N**egotiating the contracts that govern physician remuneration is one of Doctors Nova Scotia's (DNS) key responsibilities. This includes the Master Agreement, Alternative Payment Plan Agreements and the Clinical/Academic Funding Plan Agreement. The association is also responsible for helping members navigate billing, audit and appeal. Doctors Nova Scotia has compiled a range of information to help members understand the intricacies of medical billing. Whatever your question, DNS contract and billing staff are here to help.

### Billing, Fees and Funding Information

In Nova Scotia, the rules surrounding physician billing are determined by a Fee Committee comprised of representatives from DNS, the provincial government and Nova Scotia Health. Physician services are covered by Medical Services Insurance (MSI) Programs, which are administered by Medavie Blue Cross on behalf of the Nova Scotia government.

### 2019 Master Agreement and C/AFP Contracts

The most recent set of contract negotiations ended when members ratified the 2019 Master Agreement and Clinical/Academic Funding Plan (C/AFP) contracts in November 2019. With those

contracts, DNS secured \$135 million over four years for Nova Scotia's doctors. Find the details – including the full contracts – at [tinyurl.com/DNS-Negotiations2019](http://tinyurl.com/DNS-Negotiations2019).

### Billing, audit and appeal

The rules surrounding medical billing are complex. Doctors Nova Scotia works with physicians to improve billing education and explain new and updated fees. Each physician is responsible for their own billing, even when you have delegated the role to your support staff. The billing rules are outlined in the MSI *Physician's Manual* and updated through MSI *Physician's Bulletins*. It's important to stay up to date on the billing rules. ## WORKING FOR YOU

Contract negotiations don't happen in a vacuum – physicians are involved at every step along the way, from the initial surveys that determine negotiation priorities to the signing of the final contract. Six physicians served on the 2019 contract negotiation teams: Drs. Mike MacDonald, Heather Johnson and James Clarke on the Master Agreement Negotiations Team, and Drs. Mike Teehan, Kirk Magee and Christine Short on the C/AFP Negotiations Team. These physicians, along with the DNS staff members on the negotiations team, met daily with the physicians on the Members' Advisory Forums, working together to bring physicians' perspectives to the negotiating table.

In some cases, MSI may audit a physician's billings. The 2019 contract includes a commitment that first-time audits will be primarily for the purposes of education. Support is available for physicians who have received a pre-payment assessment or a post-payment audit and wish to appeal the results.

## New fees and adjustments

Physicians may apply for new fees or fee adjustments to help ensure the MSI Physician's Manual reflects modern health-care delivery. Submit a completed application form to the Fee Committee for consideration by March 31 or Sept. 30 of each year. Doctors Nova Scotia staff are avail-

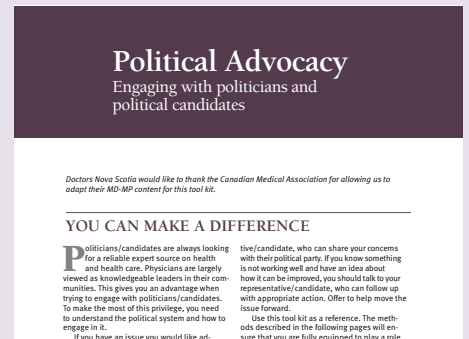

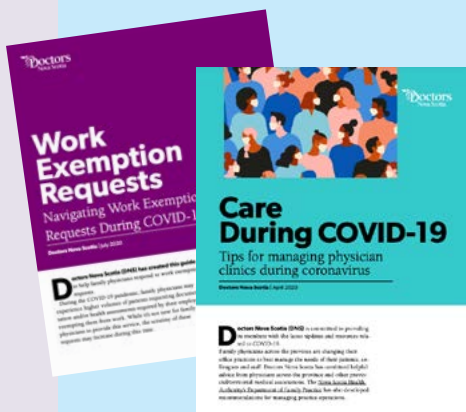

## DOCTORS NOVA SCOTIA: THE VOICE OF PHYSICIANS

On Oct. 13, 2020, Drs. Amanda MacDonald, Leisha Hawker and Robyn MacQuarrie (2020-21 President), and Nancy MacCready-Williams, CEO, appeared before the Standing Committee on Health regarding the ongoing doctor shortage in Nova Scotia.

In addition to negotiating contracts and managing the extended health and dental plan, DNS works to influence policy, advocate on behalf of patients, and contribute to health system decision-making in a way that reflects the diversity of physicians' experiences and perspectives in the province. While individual physicians represent their unique and specialized interests and needs, the association understands the broader context in which health-system change will take place. Doctors Nova Scotia continues to help shape policy by providing perspectives from all physicians.

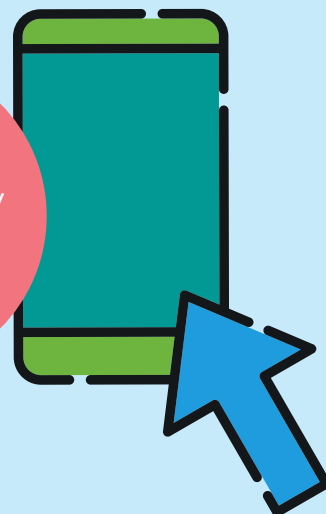
