

## Family Doctors Council 2025 FACT SHEET



The Family Doctors Council advocates for the interests of family physicians. The council's work involves developing strategies for key issues affecting the role, responsibilities and capacities of primary care physicians.

The council acts as a sounding board for health transformation, often hearing about new initiatives in the earliest stages of their development. The Department of Health and Wellness, Nova Scotia Health, the Policy and Health Issues Committee and other health-care partners often solicit feedback from this group on behalf of family physicians across the province.

The council includes members from various counties across the province. Members of the Section of Family Doctors are eligible to nominate their colleagues for a position on the council; members may only nominate physicians from their own county and may only vote within their own county. Members may nominate themselves.

**Council members** are eligible to serve a maximum of two consecutive two-year terms. The council has 22 members, which the following positions:

- **Chair** – two-year term
- **Chair-elect** – nominated by council (one-year term)
- **Past chair** (two-year term)
- **12 county representatives**, elected by the members of each county
  - Three representatives from Halifax County (two Metro and one Rural)
  - Two representatives from Cape Breton (Inverness/Victoria/Cape Breton and Richmond counties)
  - One representative from each of the other seven counties
- **Up to two family physicians** serving on the **Doctors Nova Scotia Board of Directors**
- **One resident** elected from within **Maritime Resident Doctors**
- **One medical student** elected from within the **Dalhousie Medical Student Society**
- **One Internationally Trained Physician (ITP)** as identified by consensus of the council
- **Two “flex positions,”** as identified by consensus of the council (discretionary seats); and
- President or President-elect, and/or Executive Director of the **Nova Scotia College of Family Physicians**.

The **Council Executive** includes the Chair, the Grants Coordinator, as well as the Treasurer and Secretary, who are elected from within the council membership. This year there will be a total of 11 vacancies (nine elected and two appointed), all with terms starting in November 2025:

### Elected

- Halifax counties (2 Metro, 1 Rural)
- Inverness/Victoria/Cape Breton and Richmond counties (1)
- Pictou county (1)
- Annapolis/Kings counties (1)
- Antigonish/Guysborough counties (1)
- Digby/Yarmouth/Shelburne counties (1)
- Lunenburg/Queens counties (1)

### Appointed

- Locum representative (1)
- Internationally Trained Physician (ITP) – Flex Position (1)

The council meets approximately four times a year and there is an option to attend virtually. Council members receive a \$600 honorarium for each meeting and are reimbursed for travel expenses for in-person attendance.
